**ORDER**

Today, accused is present. When the particulars of offence punishable under Section 33(w) read with Section 131 of Bombay Police Act are read over to accused, he/she voluntarily pleaded guilty to offence. He/she also filed an application/Purshis stating that he/she is voluntarily pleading guilty to the said offence and prayed to impose minimum punishment. Considering the nature of offence and taking in view the voluntariness of accused, his/her plea of guilt is accepted and leniency can so far as substantive sentence of imprisonment is concerned. Today being National Lok Adalat, I find it proper to award minimum fine amount to accused. In the result, I pass following order:-

**ORDER**


- (i) Accused is convicted for offence under Sections 33(w) read with Section 131 of Bombay Police Act, *vide* Section 252 of Criminal Procedure Code and is sentenced to pay fine of **Rs.100/-** (in words Rs. One Hundred only) in default of payment of fine amount, accused shall suffer S.I. for 01 (one) day.
- (ii) No order as to muddemal.
- (iii) Copy of this Order be given to the accused free of cost.
