1) Matter is disposed of in accordance with the terms and conditions of compromise / withdrawal pursis at Exh....19.....


2) Compromise / withdrawal pursis at Exh....19.... shall form part of Award.

5) The bail bonds of accused persons stand cancelled.


The seized mobile Samsung A71 has been returned to the Informant /
