JUDGMENT

1. That the accused **Sambhaji Shivaji Jadhav** stands prosecuted for the offence punishable U/Sec.185 of the Motor Vehicles Act.

2. The particulars vide **Exh.2** is read over and explained to the accused in vernacular to which he pleaded guilty. Today, National Lokadalat is conducted. Accused and his Ld. Advocated are present before me. He filed pursis and submitted that he is ready to plead guilty. He also submitted that he is ready to pay prescribed amount of fine. I have verified his willingness and voluntary plea of guilt.
