1. My qualification is M.D. Pathalogist. In the year 2019, I was working as medical officer as well as pathologist in Indira Gandhi Memorial Hospital, Ichalkaranji. On 24/02/2019 I have examined patient namely Nakusha Pandurang Vaze who came along with police yadi.

2. During examination of patient namely Nakusha Vaze who came with history of assault and I found following injuries:-

a. CLW on right lateral cheek with sharp object (2x1)

3. I gave her treatment and sutured the wound. The injury was simple in nature. The injury caused to the patient is possible if she is hit by sharp stone. I have issued injury certificate. Now I am shown said injury certificate it contents are true and correct. It bears my signature. Hence, the injury certificate is marked as **Exh.28**.

4. I was working in IGM hospital from year 1987 to 2016-17. It is true to say that, today I have not brought medico legal register along with me. I have examined patient Nakusha at 1.10 a.m. on 25/02/2019. I can identify the medical certificate issued by me to Nakusha. It is not true to say that, I have wrongly mentioned date 24/02/2019 on the medical

certificate as the patient visited the hospital at 12.00 a.m. and after treating her it was about 1.10 a.m.. It is true to say that, the timing of examination mentioned in the medical certificate is 8.45 p.m.. It is true to say that, while issuing the medical certificate history of the patient is mentioned. It is true to say that, the history of the patient and the kind of weapon is not mentioned on medical certificate at **Exh.28**. It is true to say that above said injury possible if a person falls. It is not true to say that on 24/02/2019 I was not working at IGM hospital. It is not true to say that I have not given medical certificate at **Exh.28**. It is not true to say that, I am deposing falsely.
