She is suffering from the mental illness. Applicant prayed for admitting her in mental hospital. The say of concerned police station was called. The concerned police station vide Exh.5 also tuned with the contention in the application. The applicant has produced on record the prescription certificate. Read the notification no.HCT-1121/163/C.R.43/DESK 3 OF THE GOVERNMENT OF MAHARASHTRA, DATED 25 MAY 2021 AND THE LETTER OF HON'BLE REGISTRAR GENERAL, HIGH COURT, BOMBAY bearing no.A.3902/1636/2021 dt.7/08/2021. As per said notification and letter all the Judicial Magistrate First Class in the State of Maharashtra to perform the function of Magistrate under Section 2(1) (I) (ii) of the Mental Health Care Act, 2017. In view of Section 3 (4) of the Mental Health Care Act, 2017, past treatment or hospitalization in Mental Health establishment though relevant, shall not by itself justify any present or future determination of persons mental illness. Thus, before passing further orders, it would be expedite to get examined the Vidya Sagar Kage from the Government Civil Hospital, Kolhapur. Hence, the order-

ORDER

- 1] Vidhya Sagar Kage be produced before the concerned panel of doctors, Government Civil hospital, Kolhapur (C. P. R. Hospital) for the purpose of her examination for determination of her alleged mental illness.
- 2] Applicant to produce Vidhya Sagar Kage before the concerned panel of doctors, Civil hospital, Kolhapur for the purpose of her examination for determination of her alleged mental illness.

- 3] Report thereof be produced on or before next date.
- 4] Issue yadi accordingly to Civil Hospital, Kolhapur.
- 5] Applicant to take note of this order.
