

-: **ORDER**:-

Today, the accused namely **Mallappa Dundappa Panhale** is appeared before the court. The accused is identified by his Ld. Advocate Shri. K.S.Marathe. The accused voluntarily pleaded guilty and accordingly filed the pursis.

I have personally verified the fact of his voluntary plea guilty from him. I have explained to him the maximum punishment for the said offence and consequences of admitting guilt, even though he pleaded guilty. Upon questioning him I am satisfied that his plea is voluntarily. In my view, considering the submissions and the nature of offence, leniency would suffice. Hence, I pass the following order -

**ORDER**



1. The accused **Mallappa Dundappa Panhale**, R/o.Durgamata Chowk, Old Chandur Road, Ichalkaranji, Tal.Hatkanagle, Dist.Kolhapur is convicted vide section 275 of the B.N.S.S., 2023 on his voluntarily pleading guilty for the offence punishable under **185** of the Motor Vehicle Act and shall pay fine of Rs.10,000/- (in words Rs.Ten Thousands only) in default to suffer simple imprisonment for Ten days.
