ORDER BELOW EXHIBIT NO. 51

The present application is filed for bringing legal representatives of the deceased plaintiff no.1 Mahamad Sahebji Mulla and plaintiff no.2 Moula Sahebji Mulla on record.

02. It is contended that, plaintiff no.1 Mahamad Sahebji Mulla died on 20/06/2020 and plaintiff no.2 Moula Sahebji Mulla died on 07/09/2016 and there are no other legal representatives of deceased plaintiff no.1 and 2 except those are mentioned in instant application. This application is supported by an affidavit.

03. Say of other sides were called and defendants filed say at Exh.52 and submitted that, the contentions in this application are totally false. No proper and valid reason given for delay caused to bring legal representatives of deceased. Hence, they prayed to rejection the application.

04. In view of Article-120 of Limitation Act the application for bringing legal representatives of deceased plaintiff ought to have filed within 90 days from the date of death of deceased plaintiffs or defendants. In instant matter death extract of deceased plaintiff no.1 Mahammad Sahebji Mulla and plaintiff no.2 Moula Sahebji Mulla shows that, they died on 20/06/2020 and 07/09/2016 respectively and instant application is moved on 20/10/2022, which is not within the period of limitation. However, as per order passed below Exh.49

delay caused in bringing legal representatives on record is condoned. Further, defendants nowhere denied that, the legal representatives mentioned in application are not representatives of deceased plaintiff no.1 Mahamad Sahebji Mulla and plaintiff no.2 Moula Sahebji Mulla. Therefore, there is no hurdle to allow the instant application. Hence, I proceed to pass following order.

:- ORDER :-

1. Application is allowed and plaintiffs are permitted to bring the legal representatives of deceased plaintiff no.1 Mahamad Sahebji Mulla and plaintiff no.2 Moula Sahebji Mulla on record after compliance of costs imposed as per Exh.49.
2. The plaintiffs shall carry out the necessary amendment in plaint on or before next date and shall supply the amended copy of plaint.
