CHARGE.

I, Shrinivas A. Kulkarni, Judicial Magistrate F.C., Peth-Vadgaon hereby charge you accused -

Mahadev Ramchandra Bagadi.

Age about – 52, yrs., Occ. - Nil,

R/o. Nilewadi, Tal. Hatkanangle, Dist. Kolhapur.

as follows -

That on 12/01/2018 at about 23.30 Hrs. on WaranaNagar to Wathar Raod, near to Shyamrao Patil High-School, village Talsande, Tal. Hatkanangale you accused drove Indica Car bearing No.MH-10-AJ-1776 in a manner so rash or negligent as to endanger human life or to be likely to cause hurt or injury to any other person and gave dash to motorcycle, bearing No.MH-10-AT-4141 – Prashant Pandurang Patil, and thereby committed an offence punishable under section 279 of The Indian Penal Code and within my cognizance.

Secondly, on the aforesaid date, time and place, you accused drove aforesaid Indica Car bearing No.MH-10-AJ-1776 so rashly or negligently as to endanger human life or the personal safety of others and gave dash to above mentioned Motorcycle rider bearing No.MH-10-AT-4141 and caused hurt to him and thereby committed an offence punishable under Section 337 of The Indian Penal Code, 1860 and within my cognizance.

Thirdly, on the aforesaid date, time and place, you accused by driving aforesaid Indica Car bearing No.MH-10-AJ-1776 so rashly or negligently as to endanger human life or the personal safety of others and and gave dash to above mentioned motorcycle rider bearing No.MH-10-AT-4141 and caused grievous hurt to him and thereby committed an offence punishable under Section 338 of The Indian Penal Code, 1860 and within my cognizance.

Fourthly, that on the aforesaid date, time and place you accused drove aforesaid Indica Car bearing No.MH-10-AJ-1776 and gave dash to above mentioned motorcycle bearing No.MH-10-AT-4141 and caused death of Prashant Pandurang Patil and your said act was rash and negligent which is not amounting to culpable homicide and thereby committed an offence punishable under section 304-A of The Indian Penal Code and within my cognizance.

Fifthly, that on the aforesaid date, time and place, you accused committed mischief by causing wrongful loss or damage to the vehicles i.e. motorcycle bearing No.MH-10-AT-4141 of more than Rs.50/- and thereby committed an offence punishable under section 427 of Indian Penal Code, 1860, and within my cognizance.

Sixthly, on the aforesaid date, time and place, you accused drove aforesaid Indica Car bearing No.MH-10-AJ-1776 at a speed or in a manner which was dangerous to the public having regard to the circumstances of the case including the nature, condition and use of the place where the vehicle is driven and thereby committed an offence punishable under Section 184 of The Motor Vehicles Act, 1988 and within my cognizance.

Lastly, on the aforesaid date, time and place, you accused did not take any step to secure medical treatment for the injured by

conveying him to the nearest medical practitioner or hospital and you did not report the circumstances of the occurrence at the nearest police station within 24 hrs. of the occurrence and thereby committed an offence punishable under section 134 (1) (b) of The Motor Vehicles Act, 1988 and within my cognizance.,

And I hereby direct that you will be tried by me on the above charge.
