CHARGE

I, V.V.Kulkarni, Judicial Magistrate First Class, Gargoti hereby
charge you accused

- 1] **Laxman Dhondiba Gojare,**
Age - 46 years, Occ. - Agri.,
- 2] **Sadhana Laxman Gojare,**
Age - 40 years, Occ. - Agri.,
Both R/o. Madilage Budruk, Tal. Bhudargad,
Dist. Kolhapur

as follows -

That on 28/02/2022 at about 17.00 in front of house of informant situated in village Madilage Budruk, Tal. Bhudargad, in furtherance of your common intention alongwith Juvenile-in-conflict with law - Aniket Laxman Gojare and Avishkar Laxman Gojare you accused No.1, voluntarily caused grievous hurt to informant - Suresh Dinkar Gojare by means of iron Katawani (लोखंडी कटावणी), which if used as weapon of offence is likely to cause death by hitting the same on informant's lips and you accused No.2 voluntarily caused grievous hurt to witness - Namdeo Gojare by means of hoe (खोरे) which if used as weapon of offence is likely to cause death by hitting the same on his right leg and thereby committed an offence punishable under Section 324 r/w. Section 34 of Indian Penal Code, 1860 and which is within my cognizance.

Secondly, on the aforesaid date, time and place, you accused No.2 alongwith Juvenile-in-conflict with law - Aniket Laxman Gojare and Avishkar Laxman Gojare in furtherance of your common intention voluntarily caused hurt to the witness and thereby committed an offence punishable under Section 323 r/w. Section 34 of Indian Penal Code, 1860 and which is within my cognizance.

Lastly, on the above date, time and place, you accused No.1 and 2 in furtherance of your common intention alongwith Juvenile-in-conflict with law - Aniket Laxman Gojare and Avishkar Laxman Gojare, intentionally abused to informant and witness and provoked them to commit the break of public peace and thereby committed an offence punishable under Section 504 r/w. Section 34 of Indian Penal Code, 1860 and which is within my cognizance.

And I hereby direct that, you will be tried by me on the above charge.
