That you above named accused issued to the complainant cheque bearing No.107919 dated 13/08/2025 for payment of Rs. 9,35,844/- drawn on an account maintained by you with the State Bank of India, branch Pimpalgaon, towards the discharge of legally enforceable debt/liability towards the complainant. Thereafter, the complainant deposited the said cheque in the State Bank of India, Branch Pimpalgaon, Tal. Bhudargad for realization. However, it were returned by the bank unpaid for the reason “**Funds Insufficient**”. Thereafter, the complainant made demand for payment of the amount of the cheque by giving you a notice in writing dated 13/08/2025. The said notice was issued to you on 16/08/2025 Despite service of notice, you failed to make the

payment of the cheque amount to the complainant within stipulated period from the receipt of the said notice and thereby you committed an offence punishable under Section 138 of the Negotiable Instrument Act.
