CHARGE

I, V. V. Kulkarni, Judicial Magistrate First Class, Gargoti hereby charge you accused -

- 1] **Yashwant Vishnu Gulambe,**
Age - 44 years, Occ. - Agri.,
- 2] **Ramesh Vishnu Gulambe,**
Age - 50 years, Occ. - Agri.,
- 3] **Abhijeet Ramesh Gulambe,**
Age - 20 years, Occ. - Education,
All R/o. Bhumkarwadi out of Hedawade,
Tal. Bhudargad, Dist. Kolhapur

as follows -

That on 13/05/2021 at about 17.00 in and in front of the house of informant – Dattatraya Govind Genge situated at Bhumkarwadi out of Hedawade, Tal. Bhudargad, you accused No.1 to 3 in furtherance of your common intention, committed house-tress pass by entering into the house of informant used as human dwelling, having made preparation for causing hurt to the informant and thereby committed an offence punishable under Section 452 r/w. Section 34 of Indian Penal Code, 1860 and which is within my cognizance.

Secondly, on the aforesaid date, time and place, you accused No.1 in furtherance of your common intention, voluntarily caused grievous hurt to informant by means of stone, which if used as weapon of offence is likely to cause death by hitting the same on right side of upper lip of informant and thereby committed an offence punishable under Section 324

r/w. Section 34 of Indian Penal Code, 1860 and which is within my cognizance.

Thirdly, on the aforesaid date, time and place, you accused No.1 to 3 in furtherance of your common intention, voluntarily caused hurt to the informant by means of fists and leg blows and thereby committed an offence punishable under Section 323 r/w. Section 34 of Indian Penal Code, 1860 and which is within my cognizance.

Fourthly, on the abovesaid date, time and place, you accused No.1 to 3 in furtherance of your common intention, intentionally abused to the informant and provoked him to commit the break of public peace and thereby committed an offence punishable under Section 504 r/w. Section 34 of Indian Penal Code, 1860 and which is within my cognizance.

Lastly that on aforesaid date, time and place you accused No.1 to 3 in furtherance of your common intention, committed criminal intimidation by threatening informant with injury to him with intent to cause alarm to him and thereby committed an offence punishable u/s. 506 r/w. Section 34 of The Indian Penal Code and which is within my cognizance.

And I hereby direct that, you will be tried by me on the above charge.
