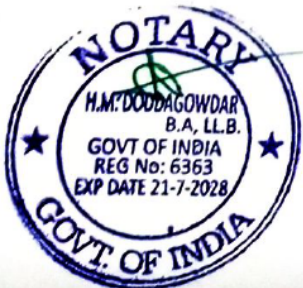
|| AFFIDAVIT ||

1. The present application is filed on my behalf, and for the purpose of this application, a Power of Attorney executed in favour of my husband is annexed herewith. 4. The said seized vehicle is necessary for me due to my health condition and my family for domestic and daily use. Therefore, it is essential and necessary that custody of the vehicle be handed over to the applicant as requested.
