**Murgud Police Station Vs. Sanjay Laxman Kamble**

**ORDER**

The accused is present before the me. Accordingly, I stated particulars of the offence punishable under section 102/117 of the Maharashtra Police Act to the accused. The substance of accusation of the accused is recorded and read over and explained to him. He submitted his plea of guilt. The prescribed punishment for the offence has been explained to him. Even the consequences thereof also explained to him. He tendered his plea of guilt.

In my view the accused pleaded guilty at his own will and without any influence. Hence, I accept that the accused is pleading guilty voluntarily and held him guilty of the said offence. Considering the nature of offences and submission of accused I come to the conclusion that lenient view is required to be taken. Hence, I pass the following Order :-

The accused is hereby convicted Under Section 275 of the Bharatiya Nagarik Suraksha Sanhita for the offence punishable under section 102/117 of the Maharashtra Police Act and he is sentenced to pay fine of Rs.500/- and in default of payment of fine to suffer S.I. for 01 day.
