Examination-in-chief by A.P.P. – Shri. S. R. Sawant :-

1) I have completed my M. B. B. S. in the year 2022. I was working as Medical officer at Ajara Rural Hospital. On 20.10.2022, patient namely Dasharath Chougule, Dropadi Chougule and Sarita Chougule came for examination. I have personally examined them.

2) On examination of Dasharath Chougule I found blunt trauma injury over his ulna of left forearm in size 10 x 10 c.m. and left ankle in size 2 x 6 c.m. Both injuries are fresh in nature. Injury over forearm is grievous in nature and injury over ankle is simple in nature. I found first injury grievous in nature as per X-ray report. First injury was cause to him by bamboo stick. Patient narrated history of assault to him by bamboo stick. I have mention his identity mark black mole over right side chick. Accordingly I had issued his medical certificate. Now is shown to me, it bears my signature and office seal. Its contents are true and correct. It marked at Exh. 38.

3) Thereafter i have examine Dropadi Chougule. On her examination I found abrasion over her right forearm in size 2 x 2 c.m. Her injury is fresh and simple in nature. I have mention her identity mark black mole over left side chick. Accordingly I had issued her medical certificate. Now is shown to me, it bears my signature and office seal. Its contents are true and correct. It marked at Exh. 39. Then I have examine Sarita Chougule. On her examination i did not find any external injury. I have

mention her identity mark black mole over right side of neck. Accordingly I had issued her medical certificate. Now is shown to me, it bears my signature and office seal. Its contents are true and correct. It marked at Exh. 40.

4) On 1.11.2022 to 3.11.2022 police officials issued request letter for collecting blood sample of informant and accused. As per request of police officials i have collected blood samples and as per procedure after seal give it to them for chemical analysis. After sealing of blood samples due to unavailability of medical seal of my office i have endorse police station seal over sample units. Thereafter, i have issue letter accordingly for the same to the department of chemical analysis. Original copy of letters sent along-with sample and office copy kept with our hospitals record. Now, its xerox copy shown to me, it's written in my hand writing, bears my signature and office seal. It marked as article 'H' for identification.

5) Injury caused to patient Dasharath and Dropadi would be quiet possible by wooden stick like (Article A) shown to me. Generally no external injury found if patient assaulted with fist and kick blows.

Chief Examination over.

Cross Examination for accused- by Adv. Shri. A. D. Patil :-

6) Patients came for examination at evening time. It is not true to say that, Dasharath was not referred for radiology examination. On external examination of patient internal injuries could not be trace out. Patients not came along-with Police Yadi. It is not true to say that, I did not find grievous and simple injuries cause to Dasharath and Dropadi Chougule. I did not seen complaint given by Hospital authority regard loss of our

office seal. I did not inform my office seniors about loss of seal and procedure accepted by me.

7) Informant and accused in this case approximately came three to four time before me. Within two to three days i have handover blood sample to police officers. I did not mark office seal over collected blood samples while it given in the custody of police. At time of hand over blood samples i did not know the procedure, therefore i have not given letter on same day. It is true to say that, due to blood samples not bear office seal concern chemical analysis department did not accept and inform to our hospital. I did not collect fresh blood samples after 9.11.2022. It is not true to say that, i did not examine patients and collect their blood samples.

8) Injury at sr. no.2 caused to Dasharath and injury caused to Dropadi would be quite possible while doing agricultural work. I did not state that, injury at sr. no.1 cause to patient Dasharath quite possible by doing agricultural work. Injuries cause to Dasharath quite possible by falling over threshold (उंबरा). As per narration of patient I mention history of assault. It is not true to say that, today i depose false.
