Examination-in-chief by A.P.P. – Shri. S. I. Sawant :-

1) I have completed my M. B. B. S. Ortho. I have been working since last 9 years in medical profession. In 2022 I had run Desai Orthopedic Hospital at Ajara. I had occupied the X-ray machine, O. T. and indoor patient.

2) On 20.10.2022 patient namely Dashrath Appa Chougule came before me for examination at 09.00 p.m. He brought by his friend and relatives. He had narrated history of scuffle. On his examination I found swelling over his forearm ulnar. He complaining pain of his hand. I had advised him for X-ray examination. As per advice I had done his X-ray. As per report, I found hairline fracture at distal 1/3rd of ulnar. The injury caused to patient probably within 6 hours.

3) As per examination I had issued his medical certificate. Now it shown to me, it bears my signature and office seal. Its contents are true and correct. It marked at **Exh. 41**. I had issued the same on 18.01.2023 to the concern police officer. Now his X-ray report shown to me. It shows hairline fracture over mid-shaft. It marked as **Exh. 42**. Said injury quiet possible by Article A shown to me.

4) Injured carry with him reference letter given to him by Rural

Hospital, Ajara. I did not gave reference of that letter in certificate at Exh.41. I had mentioned history of assault as per narration of injured. X-ray technician operate machine and prepare X-ray report at Exh.42. I had opined over the X-ray report prepared by technician. Injury caused to patient quiet possible by fallen over threshold (उंबरा). I did not admit patient as indoor patient.
