

ORDER BELOW EXH- 60.

Perused application and say. Heard counsel for both sides while filing an application and say.

2. Defendant no.6 contended that, after his appearance his mother was ill and due to her medical treatment, he would not able to contact his counsel and filed W. S. within time. Counsel for plaintiff contended that, defendant no.6 after appearance attending some dates of proceeding. Despite appearance, he intentionally not filed W. S. within time. Thus, prayed to allow the application subject to heavy cost.

3. It is not disputed that, defendant no.6 appeared in proceeding on 28.02.2025 and filed this application today. As per record, yet no W. S. order was not passed against this defendant. However, considering delay which is not cited by this defendant apparently suit proceeded without his W. S.

4. This is suit for perpetual injunction. Valuable property rights of this defendant involved in it. Defendant filed copy of his W. S. along with this application. The W. S. of defendants is just for final decision of suit. No prejudice would be caused to the plaintiff, if application allowed. Further, plaintiffs not strongly opposed to the application. Thus, considering delay caused by defendant subject to cost I pass following order,

ORDER

1. Application stands allowed, subject to cost of Rs. 500/- paid to

Legal Aid, Ajara.

2. After payment of cost amount on or before next date, W. S. of defendant will be accepted.
3. Parties to take note.
