Examination-in-chief by A.P.P. – Shri. S. I. Sawant :-

1) I have completed my M. B. B. S. On 05.01.2024, I was working as Medical officer at Ajara Rural Hospital. On that day patient namely Renuka Dashrath Khaire came before me for medical examination at 10.10 p. m. along with medical yadi. She narrated history of physical assault. I have personally examined her. I have recorded her identification mark as black mole over chest. On her examination I found

- i) Abrasion over index fingure in size 0.5 x 0.5 c. m.
- ii) Blunt trauma over left hand
- iii) Blunt trauma over right shoulder
- iv) Blunt trauma over left thigh,
- v) Blunt trauma over lower back.

2) All injuries are simple in nature and caused by blunt and hard object within 6 hours before examination. I have advised X-ray examination for injury no.1, however, patient did not ready for examination. After her examination, I have issued medical certificate. Now it shown to me, it bears my signature and it contains are true and correct. It marked as **Exh. P. 40**. Injuries at sr. no.i & iv caused to patient quiet possible by wooden stick (Article A) shown to me and further injuries quiet possible by fist blow.

Cross Examination for accused- by Adv. Shri. K. G. Patil :-

3) On 05.01.2024 I was working for 24 hours. Injured herself came for examination. No police officials came with her for examination. As per request of injured I had examined her. I denied that, I had mentioned age of injury as per narration of injured. I did not advised injured for X-ray examination before S. D. H., Gadhinglaj. Injured thereafter did not furnished X-ray report and came for treatment before me.

4) I denied that, without examining injured I have noted injuries. Identity mark of patient verified by nursing staff. I. O. of this crime not issue letter for M. L. C. report. I personally did not verified whether injured registered crime before Ajara police station. I did not recollect whether Ajara police officials demanded M. L. C. in present crime. I did not mentioned police yadi details over M. L. C. I denied that, without examination I had issued false M. L. C.
