CHARGE

I, R. D. Shinde, Judicial Magistrate First Class, Radhanagari, do hereby charge you;

Rani Ananda Lad

Age:38 years. Occ.

R/o: Ladwadi, Tal. Radhanagari,

Dist. Kolhapur

as follows;

That on 13/03/2024 at about 09.00 a.m at Mhasurli, Tal. Radhanagari, Dist. Kolhapur, you accused committed house-trespass by entering into the house of the informant namely Rajashri Santosh Patil having made preparation to cause hurt to informant and her mother-in-law, and thereby committed an offence punishable under Section 452 of the Indian Penal Code and within cognizance of this Court.

Secondly, that on aforesaid date, time and place, you accused, voluntarily caused hurt to the informant on her left hand and injured Shantabai on her right hand wrist by means of knife which is an instrument used as a weapon of offence likely to cause death and that you have thereby committed an offence punishable under Section 324 of the Indian Penal Code and within cognizance of this Court.

Thirdly, that on aforesaid date, time and place, you accused, voluntarily caused hurt to the informant by kick and fist blows, and thereby committed an offence punishable under Section 323 of the Indian Penal Code and within

cognizance of this Court.

Fourthly, that on aforesaid date, time and place, you accused damaged the T.V and household articles of the house of the informant by breaking it and committed mischief by causing wrongful loss to the same and thereby committed an offence punishable under Section 427 of the Indian Penal Code and within cognizance this Court.

Fifthly, that on aforesaid date, time and place, you accused, intentionally insulted to the above named informant by abusing her and thereby gave provocation to her intending or knowing it to be likely that such provocation will cause her to break public peace or to commit any other offence, and thereby committed an offence punishable under Section 504 of the Indian Penal Code and within cognizance of this Court.

Lastly, that on aforesaid date, time and place you accused committed criminal intimidation by threat to kill the informant with intent to cause alarm to her and that you have thereby committed an offence punishable under Section 506(ii) of Indian Penal Code and within cognizance of this Court.

And, I hereby direct that you be tried by this Court on the aforesaid charge.
