5) Offence complained of-

That you above named accused no. 1, on 23-09-2015, at about 14.00 hours, at informant's field locally known as Mal, situated at village Chakreshwarwadi, Tal. Radhanagari, Dist. Kolhapur, pretended to hold the office of Home department i.e. Police Station, as public servant or falsely personated police as holding such office and in such assumed character did or attempted to do under colour of such office, and thereby you have committed an offence punishable under Section 170 of Indian Penal Code, 1860 and within my cognizance.

That you above named all accused, on the aforesaid day, date, time and place, were a members of an unlawful assembly and the common object of which was committing offence of riot, and thereby you have committed an offence punishable under Section 143 of the Indian Penal Code, 1860 and within my cognizance.

That you all accused, on the aforesaid date, time and place, were a members of an unlawful assembly, and in prosecution of the common object of such assembly, to cause injury to the Informant namely Yashwant Laxman Randive committed the offence of rioting, and thereby you have committed an offence punishable under Section 147 of the Indian Penal Code, 1860 and within my cognizance.

That you all accused, on the aforesaid date, time and place, were a members of an unlawful assembly and in prosecution of common object of said assembly, voluntarily caused hurt to the Informant i.e. Yashwant Laxman Randive, and thereby committed an offence punishable under Section 323 read with Section 149 of the Indian Penal Code, 1860 and within my cognizance.

That you all accused, on the aforesaid date, time and place, were a members of an unlawful assembly and in prosecution of common object of said assembly, intentionally insulted Informant namely Yashwant Laxman Randive and other witnesses by assaulting and abusing, and thereby gave provocation to them intending that such provocation would cause them to break public peace or to commit any other offence, and thereby you have committed an offence punishable under Section 504 r/w. Section 149 of the Indian Penal Code, 1860 and within my cognizance.

That you above named accused, on the aforesaid day, date, time and place, were a members of an unlawful assembly and in prosecution of common object of said assembly, committed criminal intimidation by threatening informant and other witnesses with intent to cause alarm to informant and that you have thereby committed an offence punishable u/s. 506 r/w. 49 of the Indian Penal Code and within my cognizance.
