That on 06-01-2016 at about 01.30 p.m. on Radhanagari-Dajipur road, within the jurisdiction of village Shelap, you accused drove Motor Cycle bearing registration No. MH-10-BT-6214 so rashly and negligently as to endanger human life or personal safety of others and thereby you have committed an offence punishable under Section 279 of the Indian Penal Code, and within my cognizance.

2. Secondly, on the aforesaid date, time and place, you accused caused hurt to yourself by giving dash to S.T.Bus bearing registration No. MH-14-BT-3062 by driving your vehicle rashly and negligently, so as to endanger human life or personal safety of others, and thereby you have committed an offence punishable under Section 337 of the Indian Penal Code and within my cognizance.

3. Thirdly, on the aforesaid date, time and place, you accused caused grievous hurt to yourself by giving dash to S.T.Bus bearing registration No. MH-14-BT-3062 by driving your vehicle rashly and negligently, so as to endanger human life or personal safety of others, and thereby you have committed an offence punishable under Section 338 of the Indian Penal Code and within my cognizance.

4. Fourthly, on the aforesaid date, time and place, you accused with intend to cause or knowing that your are likely to cause, wrongful loss or damage to the public or to any person, caused the destruction or change

in Motor Cycle bearing No. MH-10-BT-6214 and S.T.Bus bearing registration No. MH-14-BT-3062 and or caused change in the situation thereof as destroys or diminishes its value or utility or affects it injuriously and thereby caused loss or damage to the amount of Rs. 50/- or upwards and thereby committed an offence punishable under Section 427 of Indian Penal Code and within my cognizance.

5. Fifthly, on the aforesaid date, time and place, you accused drove your car on public road, in high speed, without having regards to the conditions and circumstances of road, traffic and situation on road, and thus thereby committed an offence punishable under Section 184 of the Motor Vehicles Act and within my cognizance.
