Firstly, That on 19/11/2023 at about during 3.00 p.m to 3.30 p.m in the house of Satappa Kamble at Solankur, Tal. Radhanagari, Dist. Kolhapur, you accused No. 2 in furtherance of common intention with accused No. 1 used criminal force to informant with intention of disrobing her and thereby committed committed an offense punishable under **Section 354 (B) of Indian Penal Code, 1860** (in short IPC) r.w. section 34 of IPC

Secondly, That on aforesaid date, time and place, with accused No. 1 intending to insult the modesty of informant, uttered “तुझ्याकडे पैसे नसतील तर पैशांच्या बदली तु चल” with intention to be heard by her and hold her band and thereby committed offense punishable **under section 509 of Indian Penal Code, 1860** r.w. section 34 of IPC.

Thirdly, You both accused in furtherance of your common intention committed house trespass, having made preparations for assaulting informant and thereby committed an offence punishable under **Section 452 r/w 34 of I.P.C**

Lastly, That on aforesaid date, time and place, you accused No.1 and 2 in furtherance of your common intention, voluntarily caused hurt to the informant's husband and thereby committed an offense punishable under **Section 323 r/w 34** of IPC.
