That on 20-12-2017 at 12.30 noon at Village Gawashi, Tal. Radhanagari you accused 1 to 6 assembled with common object to commit any offence by means of criminal forces, or show of criminal force, to any person, to take or obtain possession of any property or to deprive any person of the enjoyment of right of way or of the use of water or other incorporeal right of which he is in a position or enjoyment, or to enforce any right or supposed right or by means of criminal force, or show to criminal force to compel any person to do what he is not legally bound to do, or to omit to do what he legally

entitled to do and thereby committed an offence punishable U/s 143 R/w section 149 of IPC. and within my cognizance.

02. Secondly, on aforesaid date, place and time you accused 1 to 6 in prosecution of common object used force or violence and thereby committed an offence of rioting punishable u/s 147 R/w Section 149 of IPC. and within my cognizance.

03. Thirdly, that on the aforesaid date, time and place, you accused 1 to 6 were the members of an unlawful assembly and in prosecution of common object of said assembly, committed mischief of causing damages of Rs. 50/- onwards to the pipe line scheme of informant and thereby you have committed an offence punishable under Section 427 R/w Sec. 149 of IPC and within my cognizance.

04. Fourthly, on aforesaid date place and time you accused 1 to 6 gave provocation to informant or any person intending or knowing it to be likely that such provocation will cause him to break the public peace, or to commit any other offence, and thereby committed an offence punishable U/s 504 R/w Sec. 149 of IPC and within my cognizance.

05. Fifthly, on aforesaid date, time and place, you accused 1 to 6 threatened informant with injury to their person, with intend to cause alarm to him, and thereby committed an offence punishable under Section 506 R/w Sec. 149 of I.P.C. and within my cognizance.
