I, N. P. Kakade, Judicial Magistrate First Class, Radhanagari, do hereby charge you;

1. **Rohit Tukaram Ranmale**

Age: 26 years.

2. **Tukaram Shivaji Ranmale**

Age: 51 years.

3. **Reshma Tukaram Ranmale**

Age: 42 years.

All of the above residing at :

Aknur, Tal. Radhanagari, Dist. Kolhapur

as follows;

Firstly,

That since 2022 till filing of F.I.R., at Aknur, tal. Radhanagari, Dist. Kolhapur you accused no. 1 being husband of informant and other accused being relatives of accused no. 1, in furtherance of your common

intention, subjected to the informant with cruelty for illegal demand of Rs.50,00,000/- and thereby you have committed an **offence punishable u/s. 85 r/w. 3(5) of Bharatiya Nyay Sanhita** (in short BNS),

Secondly,

That on aforesaid date, time and place, you accused No.1 to 3 in furtherance of your common intention, voluntarily caused hurt to the informant and thereby committed an offense punishable under **Section 115(2) r/w 3(5) of BNS.**

Thirdly,

That on above mentioned date and time and place you accused Nos. 1 to 3 in furtherance of common intention intentionally insulted the informant and thereby gave her provocation, intending or knowing it to be likely that such provocation will cause him to break public peace or committed any other offence and thereby committed offence punishable u/s **352 r.w. sec. 3(5) of BNS,**

Fourthly,

That on above mentioned date and time and place you accused in furtherance of common intention threatened the informant and that you have thereby committed an offence punishable under **Section 351(2) r.w. 3(5) of the BNS,**

Lastly,

That on above mentioned date and time and place you accused in furtherance of common intention threatened the informant

to cause death and that you have thereby committed an offence punishable under **Section 351(3) r.w. 3(5)** of the BNS,

Within my cognizance and I hereby direct that you be tried by this Court on the above mentioned charge.
