**C H A R G E**

I, Mahendra H. Shitole, Judicial Magistrate, First Class, Radhanagari, do hereby charge you -

**1. Shri. Vilas Piraji Sabale**

Age : 40 Occu : Agriculture

**2. Shri. Baban Piraji Sabale**

Age : -- Occu : Service

Both R/o Turambe, Tal. Radhanagari.

as follows -

That on 31-05-2015 during 3.00 p.m to 4.00 p.m. at village Turambe, Tal. Radhanagari you accused 1 and 2, in furtherance of your common intention voluntarily obstructed the informant so as to prevent her from proceeding in any direction in which she has a right to proceed, and there by you have committed an offence punishable under Section 341 R/w Sec. 34 of I.P.C. and within the cognizance of this court.

2. Secondly, on aforesaid date, time and place, you accused 1 and 2 , in furtherance of your common intention entered into or upon the property in the possession of another with intent to commit an offence or to intimidate, insult or annoy any person in possession of such property, or having lawfully entered into or upon such property,unlawfully remained there with intent thereby to intimidate, insult or annoy any such person, or with intent to commit an offence, and thereby you have committed an offence punishable under Section 447 R/w Sec. 34 of I.P.C. and within the cognizance of this court.

3. Thirdly, on aforesaid date place and time you accused 1 and 2 in furtherance of your common intention caused physical contact and advanced involving unwelcome and explicit sexual overtures towards informant, and thereby you have committed an offence punishable under Section 354-A R/w Sec. 34 of I.P.C, and within the cognizance of this court.

4. Fourthly, on aforesaid date, place and time you accused 1 and 2 in furtherance of your common intention voluntarily caused, hurt to informant and thereby you have committed an offence punishable u/s 323 R/w Sec. 34 of IPC and within the cognizance of this court.

5. Fifthly, on aforesaid date place and time you accused 1 and 2 in furtherance of your common intention gave provocation to informant or any person intending or knowing it to be likely that such provocation will cause him to break the public peace, or to commit any other offence, and thereby committed an offence punishable U/s 504 R/w Sec. 34 of I.P.C. and within the cognizance of this court.

6. I hereby direct that you accused be tried by me on the aforesaid charge.
