CHARGE

I, M. S. Todkar, Judicial Magistrate, First Class, Radhanagari, do hereby charge you -

1. Krushna Aba Jadhav.
Age 65, Occ. Agri.,
R/o. Mangewadi, Tal. Radhanagari,
Dist. Kolhapur.
2. Dattatraya Krushna Jadhav.
Age 35, Occ. Agri.,
R/o. As above.
3. Gourabai Krushna Jadhav.
Age 62, Occ. Agri. & Household,
R/o. As above.
4. Smt. Sajabai @ Bharati Rajendra Magdum.
Age 45, Occ. Agri., and Household,
R/o. As above.

as follows -

That you above named accused, on 19-05-2014, at about 22.00 hours, in the house of Informant, situated at village Mangewadi, Tal. Radhanagari, Dist. Kolhapur, in furtherance of your common intention, you committed house trespass by entering into the said house, used as a human dwelling for assaulting defacto informant and their family members, and thereby you committed an offence punishable under Section 452 r/w. Section 34 of the Indian Penal Code, 1860 and within my cognizance.

That you above named accused, on the aforesaid day, date, time and place, in furtherance of your common intention, you caused hurt to informant and her husband, father-in-law and mother in law by pelting stones, assaulting by fist and kick blows and taking bite, rashly and negligently, so as to endanger human life or personal safety of others and thereby you have committed an offence punishable under Section 337 read with Sec. 34 of the Indian Penal Code, 1860 and within my cognizance.

That you above named accused, on the aforesaid day, date, time and place, in furtherance of your common intention, voluntarily caused hurt to the Informant and their family members, by means of stones, which are likely to be caused their death, and thereby you have committed an offence punishable under Section 324 read with Sec. 34 of the Indian Penal Code, 1860 and within my cognizance.

That you above named accused, on the aforesaid day, date, time and place, in furtherance of your common intention, voluntarily caused hurt to the Informant namely Geeta Pandurang Jadhav, and thereby you have committed an offence punishable under Section 323 read with Section 34 of the Indian Penal Code and within my cognizance.

That you above named accused, on the aforesaid day, date, time and place, in furtherance of your common intention, intentionally insulted and thereby gave provocation to Informant and her family members, intending that such provocation would cause her, to break public peace or to commit any other offence, and thereby you have committed an offence punishable under Section 504 read with Section 34 of the Indian Penal Code and within my cognizance.

That you above named accused, on the aforesaid date, time and place, in furtherance of your common intention, committed criminal intimidation by threatening Informant and her family members with injury to their person, with intend to cause alarm to them and thereby you have committed an offence punishable under Section 506 read with Section 34 of the Indian Penal Code and within my cognizance.

And, I hereby direct that you accused be tried by me on aforesaid charge.
