The accused has expressed his desire to plead guilty to the above offence. He has admitted all the facts constituting offence under Section 279 of the Indian Penal Code. I have explained him the consequences of pleading guilty including conviction and punishment. Still the accused desired to plead guilty. To that effect he has filed pursis below Exh.3. It is, therefore, clear that the accused is voluntarily pleading guilty to the offence. Hence, I have no hesitation in holding him guilty on the basis of his plea. In the end I pass following order.

**ORDER**

The accused **Azim Nazir Maner** is convicted for the offence punishable under Section 279 of the Indian Penal Code vide Section 252 of the Code of Criminal Procedure and he is sentenced to pay fine of Rs.700/- (Rs. Seven Hundred only) in default to suffer simple imprisonment for 2 (Two) days.
