: C H A R G E :

I, N.K.Nagargoje, Judicial Magistrate, F. C.,Kale-Kheriwade, Tal-Panhala, Dist-Kolhapur do hereby charge you accused,

1. Ibrahim Ahemad Shaikh, Age – 62,
2. Faruq Ibrahim Shaikh, Age – 27,
3. Rajiya Faruq Shaikh, Age-21,
4. Karishma Ilai Shaikh, Age-20,

as follows :

That you accused persons on 01/11/2021 at about 9-00 a.m. in front of accused's house at Vetawade paiki Musalmanwadi, Taluka-Panhala,Dist-Kolhapur, accused No.2 Faruq voluntarily caused hurt to the head of witness Mohammad by means of sickle and accused No.1 Ibrahim voluntarily caused hurt to the arm of witness Mohammad by means of wooden stick which are an instruments used as a weapons of offence is likely to cause death and thereby committed an offence punishable **u/s. 324** read with Section 34 of the Indian Penal Code and within my cognizance.

Secondly, that you accused persons on the aforesaid date, time and place, in furtherance of your common intention, accused no.2 Faruq voluntarily caused hurt to the informant Asif by means of slapping and thereby committed an offence punishable **u/s 323** read with section 34 of the Indian Penal Code.

Thirdly, you accused persons, on the aforesaid date, time and place, in furtherance of your common intention, accused persons insulted the witnesses by words and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable **u/s.504** read with Section 34 of the Indian Penal Code and within my cognizance.

Lastly, you accused persons, on the aforesaid date, time and place in furtherance of your common intention, accused persons committed criminal intimidation by threatening the informant and witnesses to cause death and thereby committed an offence punishable **u/s. 506** read with Section 34 of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this court on the said charge.
