: CHARGE :

I, N.K.Nagargoje, Judicial Magistrate, F. C., Kale-Kheriwade, Tal-Panhala, District- Kolhapur do hereby charge you accused,

1. Tukaram @ Balu Shivaji Jadhav, Age-48
R/o-Kale, Tal-Panhala, Dist-Kolhapur.
2. Sanotsh Tukaram @ Balu Jadhav, Age-25
R/o- As above
3. Prasad Prakash Panari, Age-26
R/o- As above
4. Pradeep Tanaji Jadhav, Age-21
R/o- As above
5. Rajaram Rangrao Walvekar, Age-33
R/o- As above
6. Vikas Appa Walvekar, age-26
R/o- As above.

Firstly, you accused persons on 05-12-2020 at 6-00 p.m. at Kondmala, Savardi, Tal-Shahuwadi, Dist-Kolhapur were a member of unlawful assembly, the common object of which was to assault the informant and witness and thereby committed an offence punishable **under Section 143 read with section 149** of the Indian Penal Code and within my cognizance.

Secondly, that you accused persons on said date, time and place were a member of unlawful assembly used force or violence in prosecution of the common object of the

said assembly, viz. assaulted the informant and the witness and thereby committed an offence of rioting punishable **under Section 147 read with section 149** of the Indian Penal Code and within my cognizance.

Thirdly, you accused persons on aforesaid date, time and place, were a member of unlawful assembly and in prosecution of common object of said assembly, accused No.1. Tukaram @ Balu voluntarily caused hurt to the witness Makaji by means of slapping and kicking, accused No.3 Tukaram @ Balu voluntarily caused hurt to the informant Mulaba and witness Pandurang by means of kick fist and blows and thereby committed an offence punishable **u/s. 323 read with Section 149** of the Indian Penal Code and within my cognizance.

Fourthly, you accused persons, on the aforesaid date, time and place, persons on aforesaid date, time and place, were a member of unlawful assembly, and in prosecution of common object of said assembly, wrongfully restrained witness Makaji and thereby committed an offence punishable under **Section 341 r/w 149** of the Indian Penal Code and within my cognizance.

Fifthly, you accused persons, on the aforesaid date, time and place, persons on aforesaid date, time and place, were a member of unlawful assembly, and in prosecution of common object of said assembly, insulted the informant and witness by saying "तुझ्या आईला झवतो" words and thereby gave provocation to them intending or knowing it to be likely that such provocation

will cause them to break public peace and thereby committed an offence punishable **u/s.504 read with Section 149** of the Indian Penal Code and within my cognizance.

Lastly, you accused persons, on the aforesaid date, time and place persons on aforesaid date, time and place, were a member of unlawful assembly, and in prosecution of common object of said assembly, accused No.4 Darshana committed criminal intimidation by threatening to informant by saying 'तुला सोडणार नाही' to cause death and thereby committed an offence punishable **u/s. 506 read with Section 149** of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this court on the said charge.
