: C H A R G E :

I, N.K.Nagargoje, Judicial Magistrate, F. C., Kale-Kheriwade, Tal-Panhala, District- Kolhapur do hereby charge you accused,

1.	Ajit Mahadev Gurav, Age-28 R/o-Gurav Galli, Gharpan, Tal-Panhala, Dist-Kolhapur.
2.	Uttam @ Gotya Mahadev Gurav, Age-29 R/o- As above
3.	Ganesh Baban Gurav, Age-23, R/o- As above
4.	Mahadev Dnyanu Gurav, Age-55 R/o- As above
5.	Baban Dnyanu Gurav, Age-52 R/o- As above

Firstly, you accused persons on 22-03-2022 at 8-15 p.m. in Gurav Galli Corner at Gharpan, Tal-Panhala were a member of unlawful assembly, the common object of which was to assault the informant Sandip and witness and thereby committed an offence punishable **under Section 143 read with section 149** of the Indian Penal Code and within my cognizance.

Secondly, that you accused persons on said date, time and place were a member of unlawful assembly and in prosecution of the common object of the said assembly used force

or violence, viz. assaulted the informant and the witness and thereby committed an offence of rioting punishable **under Section 147 read with section 149** of the Indian Penal Code and within my cognizance.

Thirdly, you accused persons, on the aforesaid date, time and place were a member of unlawful assembly, and in prosecution of the common object of said assembly, accused No.3 Ganesh voluntarily caused hurt to nose of witness Pradeep by means of stick and accused No. 2 Ganesh voluntarily caused hurt to the witness Ajit by means of stick and accused No.1 Ajit voluntarily caused hurt to right leg of informant Sandip which are instruments used as weapons of offence, are likely to cause death and thereby committed an offence punishable **under Section 324 read with Section 149** of the Indian Penal Code and within my cognizance.

Fourthly, you accused persons on aforesaid date, time and place were a member of unlawful assembly and in prosecution of common object of said assembly, accused persons voluntarily caused hurt to the witnesses Pradeep by means of kick-fist and blows and thereby committed an offence punishable **u/s. 323 read with Section 149** of the Indian Penal Code and within my cognizance

Lastly, you accused persons, on the aforesaid date, time and place, were a member of unlawful assembly, and in prosecution of common object of said assembly, insulted the informant and witness by words and thereby gave provocation to

them intending or knowing it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable **u/s.504 read with Section 149** of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this court on the said charges.
