**: C H A R G E :**

I, N. K. Nagargoje, Judicial Magistrate, F. C., Kale-Kheriwade, Tal-Panhala, District- Kolhapur do hereby charge you accused,

1. Krushnat Rajaram Wakarekar, Age-32  
R/o-Majnal, Tal-Panhala, Dist-Kolhapur.
2. Yuvraj Rajaram Wakarekar, Age-35  
R/o- As above.

That you accused persons on 26-01-2020 at about 6.20 p.m. in Gat No.233 at Majgaon, Tal-Panhala, Dist-Kolhapur accused No.1 Krushnat voluntarily caused hurt to the near left eyebrow of informant Gajanan and voluntarily caused hurt to the back of witness Nathaji by means of bottle and accused No.2 Yuvraj voluntarily caused hurt on the thigh of left leg of witness Vijay by means of stick which are an instruments used as a weapons of offence is likely to cause death and thereby committed an offence punishable **u/s. 324** read with Section 34 of the Indian Penal Code and within my cognizance.

**Secondly**, you accused persons on the aforesaid date, time and place in furtherance of your common intention, accused No.1 Krushnajt and accused No.2 Yuvraj voluntarily caused hurt to the witness vijay by means of kick-fist and blows and thereby committed an offence punishable **u/s. 323** read with Section 34 of the Indian Penal Code and within my cognizance.

**Thirdly**, you accused persons, on the aforesaid date, time and place, in furtherance of your common intention, accused

persons insulted the informant and witness by words and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable **u/s.504** read with Section 34 of the Indian Penal Code and within my cognizance.

**Lastly**, you accused persons, on the aforesaid date, time and place in furtherance of your common intention, accused persons committed criminal intimidation by threatening the informant and witnesses by saying "तुम्हा तिघांना जिवंत सोडणार नाही तुम्हाला संपवितो" to cause death and thereby committed an offence punishable **u/s. 506** read with Section 34 of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this court on the said charge.
