I, N.K.Nagargoje, Judicial Magistrate, F. C., Kale-Kheriwade, Tal-Panhala, District- Kolhapur do hereby charge you accused,

1. Ambubai Dnyandev Kamble, Age-45
R/o-Nandgaon, Tal-Shahuwadi, Dist-
Kolhapur.
2. Sakhubai Nana Kamble, Age-50
R/o- As above
3. Tukaram Dnyandev Kamble, Age-26
R/o- As above
4. Amar Dnyandev Kamble, Age-32
R/o- As above
5. Manjubai Pandurang Kamble, Age-60

Firstly, you accused persons on 23-05-2021 at 10-00 p.m. in back yard of informant's house at Nandgaon, Tal-Shahuwadi, Dist-Kolhapur were a member of unlawful assembly, the common object of which was to assault the informant and witness and thereby committed an offence punishable **under Section 143 read with section 149** of the Indian Penal Code and within my cognizance.

Secondly, that you accused persons on said date, time and place were a member of unlawful assembly used force or violence in prosecution of the common object of the said assembly, viz. assaulted the informant and the witness

and thereby committed an offence of rioting punishable **under Section 147 read with section 149** of the Indian Penal Code and within my cognizance.

Thirdly, you accused persons on aforesaid date, time and place, were a member of unlawful assembly and in prosecution of common object of said assembly, accused No.1 Ambaubai voluntarily caused hurt to informant Anjana by means of bricks and accused No.2 Sakhubai voluntarily caused hurt to the right leg of informant Anjanaby meanst of stick, accused No. 4 Amar voluntarily caused hurt to the back of witness Rohit by meanst of stick, accused No.3 Tukaram voluntarily caused hurt to the shoulder of witness Pratap by meanst of stick, accused No. 5 Manjubai voluntarily caused hurt to the back of the witness Rangrao and voluntarily caused hurt to the left leg of wintess Ananda by means of stick which are an instruments used as weapans of offence, are likely to cause death and thereby committed an offence punishable u/s. **324 read with Section 149**of the Indian Penal Code and within my cognizance.

Fourthly, you accused persons, on the aforesaid date, time and place, persons on aforesaid date, time and place, were a member of unlawful assembly, and in prosecution of common object of said assembly, insulted the informant and witness by words and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable **u/s.504 read with Section 149** of the Indian Penal Code and within my cognizance.

Fifthly, you accused persons, on the aforesaid date, time and place persons on aforesaid date, time and place, were a member of unlawful assembly, and in prosecution of common object of said assembly, committed breach of order of prevention the outbreak of such disease or spread thereof issued by the District Magistrate, Kolhapur and thereby committed an offence punishable under **43 r/w section 139 of Bombay Police Act** and within my cognizance.

Lastly, you accused persons on the aforesaid, date, time and place were a member of unlawful assembly and in prosecution of the common object of said assembly, committed the breach of the orders issued by the District Magistrate, Kolhapur and thereby committed an offence punishable under **section 37 (1)(A to F) and 37(3) r/w section 135 of Bombay Police Act** and within my cognizance.

And I hereby direct that you be tried by this court on the said charge.
