**C H A R G E**

I, N.K.Nagargoje, Judicial Magistrate, F. C., Kale-Kherivade, Tal-Panhala, Dist-Kolhapur do hereby charge you accused,

1.	Sagar Ananda Patil, Age-35, R/o-T corner, near temple, Sule Tal-Panhala, Dist-Kolhapur.
2.	Tejaswini Sagar Patil, Age-25 R/o- As above.

as follows :

That you accused persons on 24-04-2021, at about 9.45 a.m. in front of informant's house at Sule, Tal-Panhala, Dist. Kolhapur, in furtherance of your common intention used criminal force to disrobe the informant Swati Prakash Patil, accused No.1 Sagar torn clothes of informant, intending to outrage her modesty and thereby committed an offence punishable **U/sec. 354(b)** r/w 34 of the Indian Penal Code and with my cognizance.

**Secondly**, you accused persons on the aforesaid date, time and place in furtherance of your common intention, accused No.1 Sagar voluntarily caused hurt to the informant Swati by beating her and accused No.2 Tejaswini voluntarily caused hurt to the informant Swati by throwing chili powder her body and Kick-fist and blows and thereby committed an offence punishable **u/s. 323** read with Section 34 of the Indian Penal Code and within my cognizance.

**Thirdly**, you accused persons, on the aforesaid date, time and place, in furtherance of your common intention, insulted the informant and witness by words and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable **u/s.504** read with Section 34 of the Indian Penal Code and within my cognizance.

**Lastly**, you accused persons, on the aforesaid date, time and place in furtherance of your common intention, committed criminal intimidation by threatening the informant and witness by saying 'तुझ आता काय खर नाही ' 'आता तुमच्या घराला जिवंत सोडणार नाही" to cause death and thereby committed an offence punishable **u/s. 506** read with Section 34 of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this court on the said charge.
