as follows :

That you accused persons on 17-04-2018 at about 06.00 a.m. at within the precinct of village Majagaon paiki Shindewadi, Tal-Panhala, Dist-Kolhapur, were a member of unlawful assembly, the common object of which was to assault the informant Chetan Shivaji Shinde and witnesses Shivaji and Usha and thereby committed an offence punishable **under section 143 read with section 149** of the Indian Penal Code and within my cognizance.

Secondly, that you accused persons on said date, time and place were a member of unlawful assembly and in prosecution of the common object of said assembly, used force or violence, viz. assaulted the informant and the witnesses and thereby committed an offence of rioting punishable **under section 147 read with section 149** of the Indian Penal

Code and within my cognizance.

Thirdly, that you accused persons on said date, time and place were a member of unlawful assembly and in prosecution of the common object of said assembly, used force or violence i.e. to assault the informant, his father Shivaji and mother Usha armed with deadly weapons namely sticks which used as weapon of offence is likely to cause death and thereby committed an offence of rioting punishable **under section 148 read with section 149** of the Indian Penal Code and within my cognizance.

Fourthly, that you accused persons on said date, time and place were a member of unlawful assembly and in prosecution of the common object of said assembly, committed house-trespass by entering into the house of informant having made preparation for assaulting the informant and witnesses, and that you have thereby committed an offence punishable under Section 452 read with 149 of the Indian Penal Code and within my cognizance.

Fifthly, you accused persons on the aforesaid date, time and place, were a member of unlawful assembly and in prosecution of the common object of said assembly voluntarily caused hurt to the informants Chetan and witness Shivaji by means of sticks which are an instrument used as weapons of offence, are likely to cause death and thereby committed an offence punishable **under section 324 read with section 149** of the Indian Penal Code and within my cognizance.

Sixthly, you accused persons on the aforesaid date, time and place were a member of unlawful assembly and in prosecution of the

common object of said assembly, voluntarily caused hurt to witness Usha by means of kicks and blows and thereby committed an offence punishable under section 323 read with Section 149 of the Indian Penal Code and within my cognizance.

Lastly,you accused persons, on the aforesaid date, time and place, were a member of unlawful assembly and in prosecution of the common object of said assembly, intentionally insulted the informant and witnesses by words and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable **u/s.504 read with Section 149** of the Indian Penal Code and within my cognizance.

And I hereby direct that, you be tried by this court on the said charge.
