I, N.K.Nagargoje, Judicial Magistrate, F. C., Kale-Kheriwade, Tal-Panhala, District- Kolhapur do hereby charge you accused,

1. Yashwant Babu Kamble, Age-59
R/o-Karanjphen, Tal-Shahuwadi, Dist-
Kolhapur.
2. Deelip Tukaram Phatak, Age-58

3. Prakash Tukaram Phatak, Age-52
R/o- As above
4. Darshana Dilip Phatak, Age-45

5. Ashwini Ashok Phatak, Age-38

Firstly, you accused persons on 06-04-2021 at 8-30 p.m. at Karanjphen, Tal-Shahuwadi, Dist-Kolhapur were a member of unlawful assembly, the common object of which was to assault the informant and witness and thereby committed an offence punishable **under Section 143 read with section 149** of the Indian Penal Code and within my cognizance.

Secondly, that you accused persons on said date, time and place were a member of unlawful assembly used force or violence in prosecution of the common object of the said assembly, viz. assaulted the informant and the witness

and thereby committed an offence of rioting punishable **under Section 147 read with section 149** of the Indian Penal Code and within my cognizance.

Thirdly, you accused persons on aforesaid date, time and place, were a member of unlawful assembly and in prosecution of common object of said assembly, accused No.2 Deelip voluntarily caused hurt to head and right hand of informant Krushnat by means of crutch (कुबडी) which is an instrument used as weapons of offence, are likely to cause death and thereby committed an offence punishable u/s. **324 read with Section 149** of the Indian Penal Code and within my cognizance.

Fourthly, you accused persons on aforesaid date, time and place, were a member of unlawful assembly and in prosecution of common object of said assembly, accused No.1. Yashwant voluntarily caused hurt to the informant Krushnat by means of kick and slapping, accused No.3 Prakash voluntarily caused hurt to the informant Krushnat by means of slapping and accused No.4 Darshana and accused No.5 Ashwini voluntarily caused hurt to the witness Janabai by means of slapping and thereby committed an offence punishable **u/s. 323 read with Section 149** of the Indian Penal Code and within my cognizance.

Fifthly, you accused persons, on the aforesaid date, time and place, persons on aforesaid date, time and place, were a member of unlawful assembly, and in prosecution of common object of said assembly, insulted the informant and witness by words and thereby gave provocation to them intending or

knowing it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable **u/s.504 read with Section 149** of the Indian Penal Code and within my cognizance.

Lastly, you accused persons, on the aforesaid date, time and place persons on aforesaid date, time and place, were a member of unlawful assembly, and in prosecution of common object of said assembly, accused No.4 Darshana committed criminal intimidation by threatening to informant by saying 'तुझ्या लेकाला इथच गाडीन व तुला पण ठार मारीन ' to cause death and thereby committed an offence punishable **u/s. 506 read with Section 149** of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this court on the said charge.
