**: C H A R G E :**

I, V.A.Lavand-Kokate, Judicial Magistrate, F. C., Kale-Kheriwade, Tal-Panhala, District- Kolhapur do hereby charge you accused,

1. Hariba Rama Katkar, Age-65  
R/o-Prole turf Borgaon, Tal-Panhala, Dist-Kolhapur.
2. Sanjay Hariba Katkar, Age-42  
R/o- As above.
3. Raghunath Keraba Katkar, Age-44  
R/o- As above
4. Uttam Baliram Katkar, Age-31  
R/o- As above
5. Bebitai Baliram Katkar, Age-65  
R/o- As above
6. Sunita Raghunath Katkar, Age-30  
R/o- As above.

**Firstly**, you accused persons on 03.03.2023 at 5.30 p.m. back yard of informant's house at Porle turf Borgaon, Tal-Panhala,Dist-Kolhapur were a member of unlawful assembly, the common object of which was to assault the informant and witness and thereby committed an offence punishable **under Section 143 read with section 149** of the Indian Penal Code and within my cognizance.

**Secondly**, that you accused persons on said date, time and place were a member of unlawful assembly used

force or violence in prosecution of the common object of the said assembly, viz. assaulted the informant and thereby committed an offence of rioting punishable **under Section 147 read with section 149** of the Indian Penal Code and within my cognizance.

**Thirdly**, you accused persons on aforesaid date, time and place, were a member of unlawful assembly and in prosecution of common object of said assembly, accused No.2 Sanjay voluntarily caused hurt to the witness Dhondiram by means of Stick and accused No.3 Raghunath voluntarily caused hurt to informant Sarika and accused No.4 Uttam voluntarily caused hurt to witness Akkatai and blows and thereby committed an offence punishable **u/s. 324 read with Section 149** of the Indian Penal Code and within my cognizance.

**Fourthly**, you accused persons, on the aforesaid date, time and place, were a member of unlawful assembly and in prosecution of common object of said assembly, committed mischief by causing wrongful loss to the property i.e. construction of informant worth Rs. 50/- or upwards and thereby committed an offence punishable **under section 427 read with Section 149** of the Indian Penal Code and within my cognizance.

**Lastly**, you accused persons, on the aforesaid date, time and place, persons on aforesaid date, time and

place, were a member of unlawful assembly, and in prosecution of common object of said assembly, insulted the informant and witnesses by words and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable **u/s.504 read with Section 149** of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this court on the said charge.
