as follows :

That you accused persons on 30-04-2018 at about 4.00 p.m. in the filed block No.289 of informant Ananda Kumbhar at Walvekarwadi, Tal-Panhala, Dist-Kolhapur, were a member of unlawful assembly, the common object of which was to assault the informant Ananda Lakhu Kumbhar and witnesses and thereby committed an offence punishable **under section 143 read with section 149** of the Indian Penal Code and within my cognizance.

Secondly, that you accused persons on said date, time

and place were a member of unlawful assembly and in prosecution of the common object of said assembly, used force or violence viz. assaulted the informant and the witnesses and thereby committed an offence of rioting punishable **under section 147 read with section 149** of the Indian Penal Code and within my cognizance.

Thirdly, that you accused persons on said date, time and place were a member of unlawful assembly and in prosecution of the common object of said assembly, used force or violence i.e. to assault the informant and witnesses armed with deadly weapons namely sticks, stone and bricks which used as weapon of offence are likely to cause death and thereby committed an offence of rioting punishable **under section 148 read with section 149** of the Indian Penal Code and within my cognizance.

Fourthly you accused persons on the aforesaid date, time and place were a member of unlawful assembly and in prosecution of the common object of said assembly, voluntarily caused hurt to the informant and witnesses by means of sticks, stones and bricks which are an instruments used as weapons of offence, are likely to cause death and thereby committed an offence punishable under **section 324 read with Section 149** of the Indian Penal Code and within my cognizance.

Fifthly, you accused persons on the aforesaid date, time and place were a member of unlawful assembly and in prosecution of common object of said assembly committed mischief by causing wrongful loss or damage to Hero Honda Splendor, articles in Ganesh

General stores and the domestic utensils belonging to informant worth Rs. 50/- or upwards and thereby committed an offence punishable **under section 427 read with section 149** of I.P.C. and within my cognizance,

Sixthly, you accused persons, on the aforesaid date, time and place, were a member of unlawful assembly and in prosecution of common object of said assembly committed house trespassed by entering into the shop of informant having made preparation for putting the informant and witnesses in fear of hurt or of assault and thereby committed an offence punishable under **Section 452 read with Section 149** of the Indian Penal Code and within my cognizance.

Seventhly, you accused persons, on the aforesaid date, time and place, were a member of unlawful assembly and in prosecution of the common object of said assembly, intentionally insulted the informant and witnesses by words and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable u/s.504 read with Section 149 of the Indian Penal Code and within my cognizance.

Lastly, you accused persons, on the aforesaid date, time and place were a member of unlawful assembly, and in prosecution of common object of said assembly, committed criminal intimidation by threatening the informant and witnesses to cause death and thereby committed an **offence punishable u/s. 506 read with Section 149** of the Indian Penal Code and within my cognizance.
