**: C H A R G E :**

I, V.A.Lavand-Kokate, Judicial Magistrate, F. C., Kale-Kheriwade, Tal-Panhala, District- Kolhapur do hereby charge you accused,

1. Ankush Ananda Khot, Age-25  
R/o- Ghungut paiki Ghungurwadi,  
Tal-Shahuwadi, Dist-Kolhapur.
2. Santosh Narayan Khot, Age-22,  
R/o- As above.
3. Ananda Appaji Khot, Age-52,  
R/o As above.

That you accused persons on 08.11.2022 at about 7-00 a.m. in informant's house at, Ghungur paiki Ghungurwadi, Tal-Shahuwadi, Dist-Kolhapur, in furtherence of your common intention, accused No.1 Ankush and accused No.2 Santosh voluntarily caused hurt to the head of informant Dilip by means of sticks, accused No. 2 Santosh voluntarily cuased hurt to the right hand and leg of informant Dilip and accused No. 1 and 2 voluntarily caused hurt to the head and head and leg of witness Sunita, Sonabai and Shripati by means of sticks, accused No.1 Ankush voluntarily caused hurt to head of witness Shahaji by means of steel strip which are an instruments used as a weapons of offence is likely to cause death and thereby committed an offence punishable **u/s. 324** and r/w 34 of the Indian Penal Code and within my cognizance.

**Secondly**, you accused persons on the aforesaid date, time and place, in furtherance of your common intention, accused No. 1 to 3 voluntarily caused hurt to the witness informant Dilip witnesses Sunita, Sonabai and Shripati by means of kick-fist blows and thereby committed an offence punishable **u/s. 323** and r/w 34 of the Indian Penal Code and within my cognizance.

**Thirdly**, you accused persons on the aforesaid date, time and place, in furtherance of your common intention, accused No. 1 to 3 committed house trespass by entering into the house of the informant Dilip Shripati Khot having made preparation for causing hurt to the informant and thereby committed an offence punishable **u/s 452** and r/w 34 of Indian Penal Code and within my cognizance.

**Fourthly**, you accused, on the aforesaid date, time and place, in furtherance of your common intention, accused insulted the informant and witnesses by words and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable **u/s.504** and r/w 34 of the Indian Penal Code and within my cognizance.

**Lastly**, you accused persons on the aforesaid date, time and place, in furtherance of your common intention, committed criminal intimidation by threatening the informant and witnesses to cause death and thereby committed an offence punishable under **Section 506** of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this court on the said charge.
