: CHARGE :

I, V. V. Khulape, Judicial Magistrate, F. C., Kale-Kheriwade, Tal-Panhala, District- Kolhapur do hereby charge you accused,

1.	Ananda Lakhu Kumbhar, Age-72 R/o-Walvekarwadi, Tal-Panhala, Dist- Kolhapur.
2.	Shalabai Ananda Kumbhar, Age-60 R/o- As above
3.	Jotiram Ananda Kumbhar, Age-33 R/o- As above
4.	Kanchan Jotiram Kumbhar, Age-32 R/o- As above
5.	Shrikant Maruti Sutar, Age-34 R/o- Wakare, Tal-Karveer, Dist- Kolhapur.
6.	Akshay Yuvraj Pandav, Age-23, R/o-Khupire, Tal-Karveer, Dist- Kolhapur.
7.	Aditya Yuvraj Pandav, Age-21, R/o- As above.

Firstly, you accused persons on 30.04.2018 at 4.00 p.m. in a field called Tamboli at Walvekarwadi, Tal-Panhala were a member of unlawful assembly, the common object of which was to assault the informant Bapu and witnesses and thereby

committed an offence punishable **under Section 143 read with section 149** of the Indian Penal Code and within my cognizance.

Secondly, that you accused persons on said date, time and place were a member of unlawful assembly and in prosecution of the common object of the said assembly used force or violence, viz. assaulted the informant and the witnesses and thereby committed an offence of rioting punishable **under Section 144 read with section 149** of the Indian Penal Code and within my cognizance.

Thirdly, that you accused persons on said date, time and place were a member of unlawful assembly and in prosecution of common object of said assembly, used force or violence i.e. to assault the informant and the witnesses armed with deadly weapons namely sticks which used as weapon of offence is likely to cause death and thereby committed an offence of rioting punishable **under section 148 read with section 149** of the Indian Penal Code and within my cognizance.

Fourthly, you accused persons, on the aforesaid date, time and place were a member of unlawful assembly, and in prosecution of the common object of said assembly, voluntarily caused hurt to the informant and witnesses by means of sticks which are an instruments used as weapons of offence, are likely to cause death and thereby committed an offence punishable **under Section 324 read with Section 149** of the Indian Penal Code and within my cognizance.

Fifthly, you accused persons, on the aforesaid date,

time and place were a member of unlawful assembly, and in prosecution of the common object of said assembly, voluntarily caused grievous hurt to head and left leg to witness Prakash by means of stick and thereby committed an offence and thereby committed an offence punishable **u/s.325 read with Section 149** of the Indian Penal Code and within my cognizance.

Sixthly, you accused persons, on the aforesaid date, time and place, were a member of unlawful assembly, and in prosecution of common object of said assembly, insulted the informant and witnesses by words and thereby gave provocation to them intending or knowing it to be likely that such provocation will cause them to break public peace and thereby committed an offence punishable **u/s.504 read with Section 149** of the Indian Penal Code and within my cognizance.

Lastly, you accused persons, on the aforesaid date, time and place, were a member of unlawful assembly, and in prosecution of common object of said assembly, committed criminal intimidation by threatening the informant and the witnesses cause death and thereby committed an offence punishable **u/s. 506 read with Section 149** of the Indian Penal Code and within my cognizance.

And I hereby direct that you be tried by this court on the said charges.
