**AWARD**

The MACP / Execution Proceeding is placed before the National Lok Adalat for amicable settlement. The parties have amicably settled the matter. Accordingly, the award is passed as follows :

1. The claim for compensation under section 163A / 166 of the M. V. Act is fully and finally settled at Rs. 17,00,000/- inclusive of the amount of compensation if any paid under No Fault Liability, costs of the proceeding and the interest.
2. Respondent No. 3 do pay compensation of Rs. 17,00,000/- within 1200 months / days from the date of the award, failing which he / it shall pay interest @ of 9 % from the date of the award till realization of the entire amount.
3. The claimant waives all other claims excepting the compensation as per the settlement.
4. There is no need to pay deficit Court fees. If any Court fees is already paid, same will be refunded.

5. The amount of of compensation shall be apportioned as follows :



8. The claimants shall furnish all the details of their Bank Accounts with IFSC Code within 8 days of the award with bank verification form.


9. Thereafter, the amount of compensation be paid to the claimants by NEFT transfer to the respective accounts of the claimants.
