

Deposition of Witness No. 03 for the Claimant.

I do hereby on solemn affirmation state that :-

Exam.-in-chief by Advocate Mr. S.N. Shinde for Claimant.

1. On 12/09/2018 I was present on duty in the chowk, situated at Hadapsar-Saswad road, near Shani Mandir and at that time I was attached in traffic branch. On that day at about 7.45 p.m. one truck gave dash to one person due to which accident occurred, driver of truck was taken into the custody by me and injured was taken to hospital, persons who were gathered on the spot of incidence. Thereafter I made phone call to police station, Hadapsar, accordingly, police staff came there and they took custody of driver and said truck. Registration number of the said truck was MH11-AL-546 and name of the driver was Satish Baburao. Crime came to be registered in Hadapsar Police Station for the said accident and during the investigation my statement came to be recorded. Now said statement is shown to me, it is the same (Advocate for insurance company has no objection to exhibit the said document) hence it is marked as **Exh. 65**. In my opinion accident took place due to the negligence of truck driver.

2. Accident took place about 30 feet away from the chowk (square), where I was standing. 2 to 3 persons gave me call informing that accident took place, hence I went on the spot of accident. It is not true to say that when I went on the spot of accident, at that time injured was not there. It did not happen that truck driver left the spot of accident alongwith truck and I obstructed him. When I came on the spot of accident with driver, at that time injured was taken to hospital.

3. It is true to say that I have not lodged any report to police station, Hadapsar. Witness voluntaries that he gave intimation to the police station. It is true to say that I have not taken the injured to hospital.

4. It is true to say that on 13/09/2018 one person was lying in unconscious condition under the bridge, situated at Pune-Solapur road. Police made enquiry with me and at that time I informed them that it was the same person to whom dash was given on 12/09/2018 by the truck.

5. It is not true to say that I do not know anything as to what happened on 12/09/2018. It is not true to say that I am deposing false that truck bearing registration no. MH11-AL-546 has given any dash to anybody and Hadapsar police seized the said truck from the spot of accident. It is not true to say that only on 13/09/2018 first time police showed me the said

person, and hence I identified him.
