

Deposition of Witness No. 02 for the Claimant.

I do hereby on solemn affirmation state that :-

Exam.-in-chief by Advocate Mr. S.K. Patel for Claimant.

1. I am serving as Jr. Clerk in Z.P. Sub-Division Work, Nilanga. Our office received summons to give evidence in respect of salary of Pandit Madhavrao Waghmare, accordingly, my superior officer authorized me to give evidence in the Court. Now said letter dated 03/10/2025 is shown to me, it bears signature of Mr. Patil, who is Dy. Engineer (Civil), Z.P. Sub-Division, Nilanga, it is marked as **Exh. 26/C.W.2.**

2. Pandit Madhavrao Waghmare used to work in our office and he was appointed on 03/12/2014 as Asst. Civil Engineer. Today, I have filed four salary slips of Pandit Waghmare for the month of July 2019 to October 2019, they are shown to me, they are the same, they bears signature of Dy. Engineer Mr. Subhash G. Kulkarni, I know his signature as I worked with him, they bear stamp of our office, they are marked as **Exh. 27 to 30/C.W.2.**

3. In the month of October 2019, Pandit Waghmare used to get gross salary of Rs. 39,236/- and after deduction he used to get net salary of Rs. 31,284/-. Today, I have brought

original service book of Pandit Waghmare, as per our record, Pandit Waghmare died on 26/11/2019. Amount of 10% of salary used to be deducted as an amount for DCPS and now said head is changed as NPS. Amount of Rs. 331/- used to be deducted for DCPS and after death of Pandit Waghmare, his legal heirs got the amount, which was deducted under the said head.

Cross Exam. by Adv. Mr. K.M. Sabale for Respondent.

4. In our department salary is drawn by Executive Engineer, Z.P, Latur as per bill forwarded by our sub division. It is not true to say that salary slips issued below Exh. 27 to 30 are with Executive Engineer, Z.P, Latur. It is true to say that Kirti, who is wife of Pandit Waghmare has got service on the basis of compensate ground and now she is working as Jr. Draftsman. Basic payment of Draftsman is Rs. 25,500/-.

5. As per our record date of birth of Pandit Waghmare is 08/03/1991. It is not true to say that salary slips below Exh. 27 to 30 are issued of higher salary with a view to help the claimants to get more compensation.
