1] Since year 2011, I have been serving as Accountant & Administrative Officer in Ashwini Accident & Nero Care Center, Latur. As per court summons, I have brought necessary record in respect of patient Shahabaj Yunus Shaikh. Said patient was admitted in our hospital from 07/06/2022 to 03/07/2022. After providing treatment, our hospital issued bill on 03/07/2022 of Rs. 3,08,800/-. Now said bill is shown to me, it is the same, it bears my signature, contents are true and correct, it is marked as **Exh. 52/C.W.3**. Our hospital received amount of the bill from the patient.

2] There is Ashwini Diagnostic Center, which is sister unit of our hospital, where X-ray & CT Scan were taken. Now bills at sr. no. 2 to 6 are shown to me, they are issued by Ashwini Diagnostic Center, they also bears my signatures, they are collectively marked as **Exh. 53/C.W.3**.

3] Ashwini Medical Stores is situated in our hospital. Now chemist bills at sr. nos. 31 to 169 are shown to me,

except bill at sr. no. 34, all are chemist bills, being an Administrative Officer of the said hospital, I am aware about the said chemist bills, patient Shahabaj Yunus Shaikh purchased prescribed medicines from the said medical shop, they are collectively marked as **Exh. 54/C.W.3**. Today I have brought summary of the said bills and total amount of the chemist bills comes Rs. 2,70,544/-. Now said summary is shown to me, it bears signature of concerned pharmacist Akash Hellale, I know his signature, as he is working with me, said summary is marked as **Exh. 57/C.W.3**.

4] Hospital bill Exh. 52 indicates that our hospital has received Rs. 25000/- from CM Relief funds. Witness voluntaries that after deducting said amount, bill of Rs. 3,08,800/- came to be issued. Except CM Relief fund, our hospital has not received any amount from any other beneficial scheme. Today, I cannot say that as to how and when amount of bill came to be paid by patient. Today, I have not brought receipts in respect payment made by way of advance by the said patient.

5] It is not true to say that on the say of relatives of Shahabaj Yunus Shaikh, excessive amount of bill was given with a view to get more compensation. It is not true to say

that amount of Rs. 25,000/- was not deducted from the total bill amount.

6] I do not know after purchasing of medicines, whether some medicines came to be returned or not. It is not true to say that as said shop is situated in our hospital and hence, I am saying that said patients purchased medicines from the said shop as per chemist bill below Exh. 54. It is not true to say that today I am deposing false.
