1. I have filed my examination-in-chief on affidavit. Its content is true and correct. (The witness has relied and proved the documents as under:

Cross-exam for Respondent No.1 by Adv. Mr. A.E.Karad

2. I am educated upto 12th standard. I am presently serving in Indian Army. It is correct that I am serving such since previously to my marriage. My deceased wife was educated upto BCA. I am ready to produce educational certificate showing her age. I am ready to produce documentary proof of her earning of Rs. 18,000/- p.m. She completed her typing course prior to the marriage. I am ready to produce proof of her earning from the typing business. The said accidental scooty is owned and recorded in my name. It is incorrect that she did not hold a valid driving license. It is correct that she was coming from ring road towards Chatrapati Shivaji square at the time of incident. It is correct that my testimonial affidavit is typo-graphed as I instructed. It is correct that the record reveals my wife sustained dash from front side. It is incorrect that I narrated the accident on hearsay basis. It is correct that I personally did not witness the incident. It is incorrect that my wife was not earning anything and I was not depending upon her.

3. I earn salary of Rs. 60,000/- p.m. It is incorrect that I filed false testimonial affidavit and have given false evidence. It is incorrect that said accident was caused due to mistake of my wife of applying all of a sudden a break to the scooty causing them to fell on the road. It is incorrect that respondent No. 1 was not at a fault in the accident.

Cross-exam for Respondent No.2 by Adv. Mr. K.M.Sabale

4. It is correct that said ring road proceeds in west-east direction towards Chatrapati Shivaji square and Latur to AUSA road passes north-south. It is incorrect that my wife was unable to drive the scooty. It is incorrect that I have deposed falsely that the bus driver by rash and negligent driving caused the accident, the age of my wife was 28 years, I have not produced any proof of her service as a clerk for earning. It is incorrect that I filed false case as the compensation I would get surely in such case against ST department. It is incorrect that I have deposed falsely.

Cross completed. No Re-Examination.
