**Examination in chief - A.P.P. for state Kakde.**

1] I have done MBBS, I am working as a medical officer at P.H.C.Kingaona since last 2 years. My duty hours on 17/07/2024 is 24 hrs. On that day at about 9.15 P.M., the injured namely **Kashinath Dattatrao Marpalwar** were came with the police letter with an alleged history of assault. He was accompanied by Savitra Kashinath Marpalwar, Madhav Kashinath Marpalwar and Pooja Kashinath Marpalwar.

2] On medical examination of **Kashinath Dattatrao Marpalwar**, Age 65 Years, I found following injuries on the person of injured.

A- blunt trauma on head front to partial region, margin size irregular, nature of injury simple, caused by wood, age of injury within 24 hrs.

B- abrasion on head front to partial region margin size irregular, nature of injury simple, caused by wood, age of injury within 24 hrs.

C- blunt trauma on back and waist region, irregular in size, nature of injury simple, caused by wood, age of injury within 24 hrs.

D- blunt trauma on right forearm, irregular in size, nature of injury simple, caused by wood, age of injury within 24 hrs.

E- blunt trauma on left hand, irregular in size, nature of injury simple, caused by wood, age of injury within 24 hrs.

4] Thereafter, I issued a medical Certificate. Now the certificate shown to me is same. It bears my signature, its contents are true. It is at **Exh.64**. I have filed copy of MLC register, which shows injury were also caused to Savitra Kashinath Marpalwar, Madhav Kashinath Marpalwar and Pooja Kashinath Marpalwar. 5] Now article-A shown to me, injuries mentioned in the above medial certificates may caused by this article.
