If it is brought to the notice of this Court that (a) the proceeding to obtain certificate was defective, (b) that the certificate was obtained fraudulently by making of a false suggestion, or by the concealment from the Court of something material to the case, (c) that the certificate was obtained by means of an untrue allegation of a fact essential in point of law to justify the grant thereof, though such allegation was made in ignorance or inadvertantly, (d) that the certificate was become useless and inoperative through circumstance, (e) that a decree or order made by a competent Court in a suit or other proceedings with respect to effects comprising property rights specified in the certificate renders it proper that the certificate should be revoked, then the heirship certificate granted shall be liable for revocation and in that circumstance the applicant shall be liable to surrender the certificate before this Court.
