J U D G M E N T**(04/06/2026)**

The accused is charged for offence punishable under Section 285 of the B.N.S. The accused is produced before me. The particulars of offence were recorded and explained to him in vernacular. He has voluntarily pleaded guilty for the same. As it is voluntarily made, I accept the same and hold in guilty for above said offence.

2. Heard the accused on the point of sentence. He pleaded for leniency as he is poor and only bread earner of his family. On considering facts of the case and submissions of the accused, I passed following order :-

ORDER

The accused **Sachin Balaji Kundgir** is hereby convicted vide Section 275 of B.N.S.S. for the offence p/u/s. Section 285 of the B.N.S. and sentenced to pay fine of **Rs.1100/- (One Thousand One Hundred only)** and in default of which to suffer simple imprisonment for 15 days.
