C H A R G E

I, S. A. Surjuse, Judicial Magistrate, First Class, Deoni, hereby charge you accused :

1) Raju @ Pandurang Ratan Kalase,
Age : 65 years, Occ : Labour,

2) Rukmin Pandurang Kalase,
Age : 55 years, Occ: Labour,

Accused Nos.1 and 2 R/o. Dhangarwadi,
Tal. Deoni, Dist. Latur.

3) Soni @ Pratibha Ananda Pimpale,
Age : 21 years, Occ: Labour,

R/o. Near Shani Mandir, Bhokar,
Tal. Bhokar, Dist. Nanded.

As follows,

That, on 10/03/2024 at about 08-00 hrs. at Dhangarwadi, Tal. Deoni, you accused No.1 in furtherance of common intention with accused Nos.2 and 3 voluntarily caused of hurt to Supriya Khandu Pokale and Kesharbai by stick, which likely to cause death, thereby you accused No.1 have committed offence punishable under Section 324 of IPC and you accused Nos.2 and 3 committed offence punishable under section 324 r.w. 34 of the Indian Penal Code and within my cognizance.

2. That on above mentioned date, time and place, you accused No.1 in furtherance of common intention with accused Nos.2 and 3 voluntarily caused hurt to informant by means of stick and thereby committed an offence punishable under Section 323 of the

Indian Penal Code, and within my cognizance.

3. That on above mentioned date, time and place, you accused No.2 and 3 in furtherance of common intention with accused No.1, intentionally insulted informant and thereby gave provocation which will cause to break public peace or commit offence and you accused No.1 have committed offence punishable under Section 504 of IPC and you accused No.1 committed offence punishable under section 504 r.w. 34 of the Indian Penal Code and within my cognizance.

4. That on above mentioned date, time and place, you accused No.2 and 3 in furtherance of common intention with accused No.1, committed criminal intimidation and to cause alarm to the informant and other and thereby you accused No.1 have committed offence punishable under Section 506 of IPC and you accused No.1 committed offence punishable under section 506 r.w. 34 of the Indian Penal Code and within my cognizance.

And I hereby direct that you accused be tried by this Court on the said charges.
