C H A R G E

I, S. A. Surjuse, Judicial Magistrate, First Class, Deoni, hereby charge you accused :

Pandurang Ramrao Biradar,
Age : 24 years, Occ : Driver,
R/o. Yenki, Tal. Udgir, Dist. Latur.

As follows,

That, you accused, on 02/05/2025 at about 13.30 hrs. at Borol Chowk to Lasona Chowk road, near Nagar Panchayat Deoni, in front of Inden Gas shop, drove four wheeler Maruti Suzuki Swift Dezire bearing No. MH-24-AU-2635 on a public way in a manner so rash or negligent as to endanger human life or to be likely to cause hurt to any other person and thereby committed an offence punishable under section 281 of the Bhartiya Nyaya Sanhita and within my cognizance.

2. Secondly, you accused on the aforesaid date, time and place drove aforesaid vehicle so rashly or negligently as to endanger human life, or the personal safety of others, and caused hurt to the informant and thereby committed an offence punishable under section 125(a) of Bharatiya Nyaya Sanhita, and within my cognizance.

3. Secondly, you accused on the aforesaid date, time and place drove aforesaid vehicle so rashly or negligently as to endanger human life, or the personal safety of others, and caused grievous hurt to the informant and thereby committed an offence punishable under section 125(b) of Bharatiya Nyaya Sanhita, and within my cognizance.

4. Secondly, you accused on the aforesaid date, time and

place drove Maruti Suzuki Swift Dezire bearing No. MH-24-AU-2635 on a public way in a manner so rash or negligent and committed mischief with motorcycle bearing No.M.H.-24 B.Q.-0801 with intend to cause wrongful loss or damage, and thereby committed an offence punishable under section 324(2) of Bhartiya Nyaya Sanhita, and within my cognizance.

5. That you accused, on the aforesaid date, time and place, you drove aforesaid vehicle on public road in dangerous manner and high speed which is dangerous to the life of public, and thereby committed an offence punishable under Section 184 of the Motor Vehicle Act and within my cognizance.

6. That you accused, on the aforesaid date, time and place, after the accident you did not provide medical aid to the victim and thereby committed an offence u/s.177 in contravene of 134(a) of the Motor Vehicles Act, and within my cognizance.

7. That you accused, on the aforesaid date, time and place, after the accident you failed to inform to the nearest police station about the incident, and thereby committed an offence u/s.177 in contravene of 134 (b) of the Motor Vehicles Act, and within my cognizance.

And I hereby direct that you accused be tried by this Court on the said charges.
