**:: ORDER ::**

Today, the accused is appeared and filed pursis (Exh.8). I read over and explained particulars of the offence and punishment to him. He voluntarily filed pursis and pleaded guilt of offence, inspite informed punishment and its consequences. Hence, I accepted his guilt. This is fit case to proceed further to convict them.

2. The accused persons submitted that he is poor and only earning member of his family and prayed for lenient view while awarding sentence. Taking into consideration the nature of the offence and the aforesaid submission and reason, I am of the opinion that the following sentence will meet the ends of justice. Hence, I pass following order.

**ORDER**

1.	The accused is convicted for the offence punishable under Section 24 in contreven section 6 (b) of The Cigarettes and other tobacco products (Prohibition of advertisement and regulation of trade and commerce, Production, Supply and distribution) Act -2003 under Section 275 of Bharatiya Nagarik Suraksha Sanhita and pay fine of amount of Rs.200/- (Rupees Two Hundred) in default to suffer simple imprisonment for 2 (two) days.
2.	The muddemal being injurious to health be destroyed after the appeal period is over.
3.	Informed right of appeal and its limitations to the accused.

4.	The copy of order shall supply free of cost to the accused.
5.	Order dictated on computer and pronounced in open Court.
