**CHARGE**

I, S. A. Surjuse, Judicial Magistrate, First Class, Deoni, hereby charge you accused :

- 1) Mangesh Jindas Ekdare,  
Age : 29 years, Occ : Driver,
- 2) Shailesh Jindas Ekdare,  
Age : 25 years, Occ: Driver,
- 3) Mangesh Gurunath Patri,  
Age : 23 years, Occ: Driver,
- 4) Ashok Mohanrao Ekdare,  
Age : 47 years, Occ: Agriculturist,

All R/o. Deoni Bu., Tal. Deoni, Dist. Latur.

As follows,

That, on 26/06/2022 at about 18.30, in the vicinity of village, Deoni, Tal. Deoni, Dist. Latur, you accused No.1 and 2 in furtherance of common intention with accused No.3 and 4 voluntarily caused grievous hurt to the witness Sanjay Pandit Ekdare by means of Hockey stick and Axe stick respectively which are likely to cause death and thereby you accused No.1 and 2 committed an offence punishable under section 326 of Indian Penal Code and you accused No.3 and 4 committed offence punishable under section 326 r.w. 34 within my cognizance.

2. That, on above mentioned date, time and place, you accused No.1 and 2 in furtherance of common intention with accused No.3 and 4 voluntarily caused of hurt to Sanjay Ekdare and Govind Ekdare and Shubham Ekdare by hockey stick and Axe stick respectively, which likely to cause death, thereby you accused No.1 and 2 have committed offence punishable under Section 324 of IPC and you accused No.3 and 4 committed offence punishable under section 324 r.w. 34 of the Indian Penal Code and within my

cognizance.

3. That, on above mentioned date, time and place, you accused Nos.1 to 4 in furtherance of common intention voluntarily uttered obscene words in public place, which caused annoyance to informant and other, thereby you have committed an offence punishable under Section 294 r.w.34 of Indian Penal Code and within my cognizance.

4. That, on above mentioned date, time and place, you accused No.3 in furtherance of common intention with accused Nos.1, 2 and 4 voluntarily caused hurt to Govind and Shubham Ekdare by means of kicks and blows and thereby you accused No.3 committed offence punishable under section 323 of the Indian Penal Code and you accused Nos.1, 2 and 4 committed offence punishable under section 323 r.w. 34 and within my cognizance.

5. That on the aforesaid date, time and place, you accused in furtherance of common intention committed criminal intimidation by threatening the said informant and witnesses to cause injury to them with intent to cause alarm to them and thereby you committed offence punishable under section 506 r.w. 34 and within my cognizance.

And I hereby direct that you accused be tried by this Court on the said charges.
